Comments from District Attorney – Funding Request. The District Attorney was not in attendance. No action taken.

Consider Bid for Compactor – Landfill. Chairman Stephens recognized County Administrator Thomas who stated a copy of the bid tabulation was in the Commissioners' packet. Yancey Bros was the lowest bidder for a 2024 CAT Model 836 Compactor in the amount of \$1,049,467. County Administrator Thomas stated the compactor price includes a five year buy back guarantee of \$389,900, a trade-in value of \$300,000 for the current machine and a delivery date of August 2025 and is recommending approval by the Board. Commissioner Barber made the motion to approve the compactor purchase. Commissioner Barber seconded the motion, a vote was taken and unanimously approved.

Consider Approval of Budget Amendments. Chairman Stephens recognized County Administrator Thomas who stated our consultant, Perry Henry is proposing the budget amendments for fiscal year ending June 30, 2024 which has a net zero change in dollar value and is part of the finalizing process of the audit and recommends approval to the Board. Commissioner

Davis made the motion a approve the amendments, a copy of which is attached. Commissioner Barber seconded the motion, a vote was taken and unanimously approved.

Consider Approval of Errors & Releases. Chairman Stephens recognized County Administrator Thomas who stated a copy of the Errors and Releases were included in the Commissioners' packet County Administrator Thomas stated the Tax Commissioner and the Board of Assessors have approved and is recommending approval by the Board. Commissioner Barber made a motion to approve the Errors and Releases, a copy of which is attached. Vice Chairman Brinson seconded the motion, a vote was taken and unanimously approved.
