Chairman Stephens called the regular meeting to order at 9:00 a.m. After the call to order, County Attorney Kirbo gave the invocation and all those assembled pledged allegiance to the flag of the United States of America.

APPROVAL OF AGENDA

Commissioner Davis made a motion to approve the agenda, as presented. Commissioner Brock seconded the motion, a vote was taken and unanimously approved.

APPROVAL OF MINUTES

Commissioner Anderson made a motion to approve the minutes of the Commissioners' meeting held September 24, 2024, as presented. Commissioner Brock seconded the motion, a vote was taken and unanimously approved.

OLD BUSINESS

There was no Old Business.

NEW BUSINESS

Consider Approval of Tractor Bid – Public Works. Chairman Stephens recognized County Administrator Thomas who stated a copy of the bid tabulation was in the Commissioners' packet. Ag Pro was the lowest bidder for a 2025 John Deere 6120E tractor in the amount of \$70,243.89. County Administrator Thomas stated the tractor will have a two-year, 2,000-hour warranty and will be available April 2025 and is recommending approval by the Board. Commissioner Davis made the motion to approve the tractor purchase. Commissioner Barber seconded the motion, a vote was taken and unanimously approved.

Consider Approval of Mower Bid – Public Works. Chairman Stephens recognized County Administrator Thomas who stated a copy of the bid tabulation was in the Commissioners' packet. Ag Pro was the lowest bidder for a 2025 Bush Hog 2215 batwing mower in the amount of \$21,500. County Administrator Thomas stated the mower will have a one-year warranty on the machine and ten-year warranty on the gearbox and will be available in three to four weeks and is recommending approval by the Board. Commissioner Barber made the motion to approve the mower purchase. Commissioner Anderson seconded the motion, a vote was taken and unanimously approved.

Consider Approval of Proclamation – Retired Educator's Day. Chairman Stephens recognized County Administrator Thomas who stated a copy of the Proclamation was in the Commissioners' packet. County Administrator Thomas stated in previous years the Board has approved a Proclamation for Retired Educators Day at the request of the Board of Education. The Proclamation recognizes November 3, 2024

as Retired Educators Day in the State of Georgia. and is recommending approval by the Board. Commissioner Davis made a motion to approve the Proclamation, a copy of which is attached. Commissioner Anderson seconded the motion, a vote was taken and unanimously approved

Consider Board Appointment – Board of Assessors. Consider Appointments. Chairman Stephens recognized County Administrator Thomas who stated a copy of the letter from Gloria Freeman was included in the Commissioners' packet requesting reappointment to the Board of Assessors. County Administrator Thomas stated the new term will begin on October 26, 2024 and end on October 25, 2027. County Administrator Thomas recommended approval by the Board. Commissioner Brock made a motion to approve the reappointment. Commissioner Barber seconded the motion, a vote was taken and unanimously approved
